IV. Atlanta Police Department Zone 4 Update – Lt. Gruen of APD - Geno Yoscovitz, Public Safety Chair

- a. Aggravated assault for beats 403, 408, and 402. 9 in 28 days. 9 burglaries in same window, as well as 7 vehicle larcenies (broken windows, laptops taken) and 4 vehicle thefts. Murder and rape down for this 28 days. Slider crimes and keys in cars and still the number of nuisance crimes.
- b. City-wide, looking at a 7% decrease compared to this time last year (acknowledges we were looking at lower numbers last year because of COVID). Zone 4, however, we are up 8% since this time last year.
- c. Running details every week -- 8pm 4am on Friday, Saturday, Sunday. Captain Clayton from Zone 5 has been spearheading this, and every zone has been dedicating people. We will see if we will
- d. New commander over vehicle larceny unit -- doing a good job of sharing vehicle descriptions with all of the officers. Lt. Marg (spelling?).
- e. Cascade Corridor between Ralph David Abernathy, Avon, Donnelly, Beecher... lots of nuisance crimes. But Gruen says officers are in these areas.
- f. Questions: Barbara Burson asks about accident on Campbellton Road yesterday pedestrian hit. 50 year old woman killed, says Gruen. Vehicle stayed on scene. Campbellton/Stanton intersection.
- g. Terra Washington asks: what are the actual numbers on rapes and murders during the last 28 day period? Last year 161 murders this time last year, now at 131... cumulative? 13% uptick from last year. Relative to this time last year, down 28% in murders city wide...
- h. Follow-up from Terra: what can we do to keep the community safe? Are we seeing an increased presence in the community?

- c. Zoning Kyle Lamont
 - i. Fort Mac Board approved preliminary plans at their last board meeting. TD Jakes will continue to do community engagement re: how they develop that site.
 - ii. Avon Subcommittee met. Mrs. Trimble and Kyle Lamont are reps. 8 acres in the Murphy Triangle area. Looking to make it a holistic plan between Murphy Crossing, Cut Rate Box, and the Avon site.
 - iii. Murphy Crossing Still in quiet phase, RFP
 - iv. Lee/Tucker Avenue -- Kyle says the community will revisit the plans from a year ago so the community remains apprised. DJ this Saturday with food for the homeless.
 - v. Tucker Avenue/Atlanta Land Trust permitting working through red tape at the city (lots of delayed)
 - vi. Atlanta Land Trust (OCCO to Make Recommendation to NPU-S) -- voting matter this evening to determine whether we will take this to the NPU
 - 1. At the last Zoning meeting, residents asked that ALT reach out to immediate neighbors near the Donnelly site. ALT did flyering on Peeples and Donnelly so that all neighbors have been reached. 1024 Donnelly. 1 mile from West End station. Directly across from BeltLine Westside trail OC access point. 5 parcels, 3.5 acres total. But only 1.5 acres are developable because of streams and sewer easement.
 - 2. 42 units proposed from 1-3 bedrooms. All for sale.
 - 3. Preserving the stream buffer, save for a proposed pathway that will connect Donnelly to Lawton portion. Eliminated original plans for garage parking will instead do surface and street parking.
 - 4. Market rate -- currently doing a market study
 - 5. The historic designation will follow the parcel even if rezoned
 - 6. Traffic off Peeples/Donnelly -- traffic -- will anything be done to address the traffic through-put?

- a. They will work on narrowing road, adding speed bumps, etc. To make it more pedestrian friendly.
- 7. Noise impact study? No, not required as part of the process.
- 8. Recommendation of Zoning and Land Use Committee to move to NPU. Neighborhood votes yes. No opposition.
